("SHSD" or "the Committee")

TERMS OF REFERENCE

1. CONSTITUTION

- 1.1 The SHSD was established to give effect to the requirements set out in the Companies Act and the recommendations in the King Code to the extent set out in these Terms of Reference.
- 1.2 The committee is constituted as a standing committee of the board of directors of Kumba to perform the statutory duties in terms of section 72(4) of the Companies Act, read with Regulation 43 of the Companies Regulations related to safety, health, environmental and sustainable development matters, and to perform all other duties assigned to it by the Board as set out in these Terms of Reference.
- 1.3 In accordance with Regulation 43(2) of the Companies Act, the committee will also perform the functions related to safety, health, environmental and sustainable development matters on behalf of the subsidiaries of Kumba Iron Ore Limited.
- 1.4 These terms of reference are subject to the provisions of the Companies Act (*as amended*), the Company's Memorandum of Incorporation, the recommendations in the King Code, the JSE LR and any other applicable law or regulatory provision and should be read together with the Governing Principles Regulating Kumba Board Committees.
- 1.5 In respect of the statutory duties of the Committee as set out below, the Committee shall be accountable to shareholders and report to shareholders as provided for in the Companies Act. In respect of all other duties as contained in these terms of reference, the Committee shall be accountable and report to the Board.
- 1.6 The Committee shall have decision-making power in respect of its statutory duties and such other duties, if any, where decision-making power has been specifically delegated by the Board to the Committee in these terms of reference. In respect of all other duties as contained herein, the Committee shall only have the power to make recommendations to the Board.
- 1.7 Committee meetings shall be held four times a year, unless agreed otherwise with the Committee Chairperson.

2. COMPOSITION

- 2.1 The Chairperson, who must be an independent non-executive director, and members of the Committee shall be nominated by the Nominations and Governance Committee and appointed by the Board. The Committee shall comprise of at least three members, the majority of whom shall be independent non-executive directors.
- 2.2 In the absence of the Chairperson, the members present may nominate and elect one of their members to chair the meeting, provided the member is an independent non-executive director.
- 2.3 Invitations to attend the Committee meetings shall be extended to:
 - the Executive Heads of Technical & Projects, SHE and Corporate Affairs;
 - Risk and Internal Audit , and
 - any other senior executives and professional advisors as deemed appropriate.

3. **ROLE**

The role of the committee is to ensure that the manner in which the Company governs performance related to safety, health, environmental and sustainable development matters and that the Company conducts itself as a responsible corporate citizen. In addition, the Committee carries out its statutory duties in terms of the Companies Act.

4. **RESPONSIBILITIES**

The Committee shall operate within the Board's delegation of authority.

In discharging its responsibilities to the Board and shareholders, the Committee will:

- monitor and report on the Company's safety, health, environmental policies and sustainable development. The key function of the committee is to act as the social conscience of the Company and to ensure that the Company is and is seen to be a responsible corporate citizen; govern compliance with applicable law, adopt non-binding rules, codes and standards; and adopt a stakeholder-inclusive approach that balances the needs, interests and expectations of material stakeholders in the best interest of the Company over time in a manner that supports the setting and achieving of its strategic objectives. (*King V™ principles 3, 4, & 6*);
- assist the Board to discharge its responsibility with respect to the approval, implementation, and monitoring of policies and practices that facilitate the Group's responsible corporate citizen credentials thereby ensuring that the Company is operating in an ethical manner;
- annually confirm fulfilment of the Committee's mandate for disclosure in the Integrated Report;
- identify the committee's focus areas for each financial year and planned areas for future focus for inclusion in the integrated report
- approve the Chairperson's letter for inclusion in the Integrated Report;
- approve the SHSD section of the Sustainability and Climate Change Report ; and
- approve the indicators included in the assurance scope as it relates to the Committee and the level of assurance for the Sustainability Report.

4.1.1 **Policy and Planning**

In fulfilling its responsibilities, the committee shall ensure the development and implementation of relevant policies and plans in order to:

- 4.1.1.1 recommend to the board, policies and guidelines for matters relating safety, health, environmental policies and sustainable development;
- 4.1.1.2 review reports on the policies and performance of the Company, its subsidiaries and the progressive implementation of its safety, health, environmental policies and sustainable development;
- 4.1.1.3 review key indicators on accidents and incidents and, where appropriate, ensure that such information is communicated to other companies managed by or associated with the Company;
- 4.1.1.4 recommend to the Board for adoption, substantive national and international regulatory and technical developments in the fields of safety, health, environmental and sustainable development;
- 4.1.1.5 encourage participation, co-operation and consultation on safety, sustainable development, health, environmental matters of governments, national and international organisations, supranational authorities such as the European Union, other companies and other associations.

4.1.2 **Risk management**

To support the Board in ensuring effective risk management oversight, specifically in relation to material risks within its scope, the committee will:

- 4.1.2.1 ensure the effective monitoring of these risks and that potential opportunities are considered as appropriate;
- 4.1.2.2 consider and review executive management's reports on the design and implementation of appropriate risk responses, overseeing that the risks are managed within the approved levels of appetite and tolerance and the integration and embedding of risk management in the business activities and culture of the Company;
- 4.1.2.3 obtain confirmation that there is adequate assurance and that controls in relation to these risks are appropriate in design and effectiveness; and
- 4.1.2.4 inform the board of its findings and recommendations in respect of material risks within its scope, which may have an impact on the Company.

4.2 OVERSIGHT AND MONITORING

The committee must exercise oversight and monitor:

4.2.1 The Company's activities, having regard to any relevant legislation, other legal requirements or prevailing codes of best practice, with regard to matters relating to:

4.2.1.1. Social and economic development, including the Company's standing in terms of the goals and purposes of:

4.2.1.1.1. the 10 principles set out in the United Nations Global Compact Principles as set out in Annexure "A" hereto;

4.2.1.1.2. the 10 principles of the International Council on Mining and Metals (ICMM) as set out in Annexure "B" hereto;
and

4.2.1.1.3. the 17 United Nations Sustainable Development Goals (SDGs) as set out in Annexure "C" hereto.

4.2.1.2. The **environment, health and safety**, including the impact of the Company's activities and of its products or services;

4.2.2. All matters relating to **safety, health and the environment**, by:

4.2.3.1. Monitoring of and providing guidance on the Company's safety, health and environmental policies and strategies;

4.2.2.2. Considering the areas of significant safety, health, sustainability and environmental risk and determining whether management is managing these effectively;

4.2.2.3. Reviewing of the scope and results of any safety, health and environmental audit on the effectiveness of the Company's safety, health and environment policies, including regulatory compliance audits.

4.2.2.4. Reviewing the management of and the Company's performance against targets in respect of energy and greenhouse gas emissions;

4.2.2.5. Considering the major findings of internal and external investigations into material safety, health and environmental incidents, management's response thereto and, where necessary, making of recommendations to the Board in respect of the same.

- 4.2.3. Considering matters relating to regulatory compliance within the mandate of the Committee:
 - 4.2.3.1. Consider the regulatory compliance report and approve the regulatory compliance plan
 - 4.2.3.2. Reviewing reports on the management of and compliance with permitting and mineral rights
